LIMITATION ON AMOUNT OF LIQUOR TO BE SUPPLIED The quantity of liquor supplied as part of a delivery must not exceed more than two 750ml bottles of wine, twelve containers (not more than 375ml per container) of beer, cider or pre-mixed spirits, or a combination of one 750ml bottle of wine and six containers (not more than 375ml per container) of beer, cider or pre-mixed spirits.

DELIVERY CONDITIONS The licensee must ensure that delivery arrangements include relevant provisions. regarding the prohibition on the supply of liquor to a person under the age of 18 years. requiring proof of age to be sighted where appropriate. that liquor is not delivered and left at unoccupied premises; and that liquor is not delivered to anyone who appears to be intoxicated.

PROHIBITION ON DELIVERY OF LIQUOR TO MINORS Liquor must not be supplied or delivered to a person under the age of 18 years.
